1 Curriculum Foundation

1.1. Philosophical Foundations

Nursing education refers to the philosophy of nursing which is the main guideline for the nursing profession. Nursing philosophy is the values, beliefs, and perspective of nurses on the phenomenon that is the focus of the main study, namely humans who are in the healthy-sick range who have basic needs. Nursing believes that humans and humanity are the central point of every health service effort by upholding human values in accordance with Pancasila and the 1945 Constitution. Departing from this belief, nursing views four basic concepts known as the nursing paradigm, namely human, environmental, health, and nursing.

Nursing education (Ners) which is a pacta education program at the higher education level, was developed by departing from the above philosophical views on nursing guided by the pacta of the Qur'an and hadith, which looks at four basic concepts, namely human, healthy, environment / society and nursing which is hereinafter known as the nursing paradigm, from an Islamic point of view

Human

Humans as recipients of nursing care both individually, family and community, as complete and unique beings in their lives experience a cycle of growth and development and continue offspring.

Nursing views humans as whole beings with a socio-spiritual bio-psycho component. Very relevant to the Islamic view that man is a complete and perfect being in the process of his creation, this is stated in the Qur'an.

" Verily we have created man in the best possible form" (Qs At-Tiin, verse 4)

Human beings consist of Bio-psycho-socio-spiritual aspects that are affirmed in the Qur'an, which are described below:

a. Biological aspects (Physical)



Man is said to be a physical aspect, because man has a body or form can walk, hear, see and try to meet all his needs, needs to eat and drink, and will suffer damage as stated in the Quran.

And We did not make them (apostles) a body that did not eat food and they did not live eternally. (Surah Al Anbiya, verse 8).

b. Spirit Aspect

Humans can walk and move to carry out their activities as creatures, because of the spirit element as a mobilizer without it the body element is a physical figure who is still and cannot do anything, as in the word of Allah SWT.

So when I have perfected the event (man) and I blow to him my spirit (creation), then let you (angels, jinns and demons) bow down by prostration (QS. Shaad, verse 72)

c. Aspects of the Soul

Humans are indeed created very perfectly, by having their human nature in the form of psychological aspects that do not exist in other creatures such as animals consisting of spirits, bodies and do not have a soul and reason so that humans are animals that have aspects of humanism because of the psychological aspects given by the creator.

(i.e.) believers and their hearts are at peace by remembering Allah, remember only by remembering Allah the heart is at peace (QS, Ar-Rad, verse 28)

d. Social aspect

Human beings as social beings are made up of different tribes and groups and they cannot live alone but rather must live together with interdependence, affirmed in the Qur'an.



O man, verily, we created you from a man, a woman, and made you into nations and tribes, that you might know one another. (Qs AI Hujurat, verse 13)

e. Aspects of common sense

Man is a creature given reason, as a basis in life to be able to know and be grateful, without reason man cannot process all phenomena around him, as in the Qur'anic verse

Say whether there are those who know and those who do not know, indeed the intelligent can receive lessons (Az-Zumar, 9:39)

Man who has been given a higher level of reason than other creatures and Allah Almighty affirms for man who is knowledgeable and uses his reason, in the verse below:

Allah exalts believers among you and those who are given knowledge of some degree (QS. Mujaadalah, verse II)

Health

Healthy is a condition where there is a physical, emotional stability, free from disease and disability and has a social and economic productivity (WHO. Health Law No 23 1999).

Healthy is an individual's responsibility that must be realized in maintaining his life, through promotive, preventive and curative efforts. Healthy is defined by the ability of individuals, families, groups or communities to make realistic goals and the ability to mobilize the energy and available resources to achieve those goals effectively and efficiently.



In the view of Islam healthy is a gift that must be maintained and interpreted as something to be grateful for, and must be considered properly as in the hadith of Bukhari and Muslim it is said *that whoever is healthy has a healthy body. peace in his heart and having food for his day, so it was as if the whole world was bestowed upon him ",* so in other words healthy is a happy condition, and sometimes people often forget the consequences of the gifts given so that in the hadith it is also affirmed "*there are two things that people often neglect, namely healthy and leisure"* (HR Bukhari and Muslim).

To achieve a healthy condition Islam gives many instructions including QS Ar-Ra'd, 28)

"Remember, only by remembering Allah does the heart become at peace" (HR. Ahmad and Al Haqi)
"Consider five things before the coming of *five things, namely: I*) the *period* of your life before your death, 2)
your health before the coming of sickness, 3) your leisure before the coming of your narrowness, 4) your
youth before the coming of *old age, and 5*) your rich before the coming of poverty" (Al Hadith)

"If you hear the news that there is a plague in an area, then do not enter that area and if you are in it, do not go out of that area."

Furthermore, in the perspective of Islam, healthy is said to be a condition of prosperity both physically and spiritually and a productive state with the advice not to neglect leisure time. In addition, Islam also provides firmness to the concept of healthy, if humans experience unhealthy or sick do not be discouraged, but every disease has a cure and all kinds of diseases can be cured with the help of Allah SWT, as in the Qur'an and hadith below:

when I am sick, God also heals." (QS. Ash-Shu'araa Verse 80) "...

For this reason, Islam insists on humans to achieve a healthy condition, by immediately making efforts to deal with it in the belief that every disease must have a treatment



"Treat you, O man, for surely Allah does not bring down a disease without lowering the cure. except old sickness and death" (HR. Ashabus Sunah)

Milieu

What is meant by the environment in nursing is a factor that can affect human health which includes the external and internal environment, the internal environment is that which comes from within the human itself which includes genetics, biological maturation, sex, emotions and predisposition to diseases and behavioral factors while what is meant by the external environment is the environment around humans, including the physical and biological environment, social, cultural and spiritual.

In the Islamic view, humans are obliged to pay attention to and protect the environment both externally and internally and make efforts so that the environment remains beneficial for life.

a. External Environment

In Islam the external environment has a much broader meaning, where the environment describes everything that Allah Almighty created around nature so that humans are more competent and can learn their lessons (Qs Al Baqarah, verse 164; Qs Al Jaatsiyah, verses 3-7.; Qs AL Araf, verse 57). Maintaining and safeguarding the environment is a compulsory behavior in Islamic teachings, and its benefits are for the welfare of human beings themselves, as in *Qs Al -Ankabut, verses 36-37; . Qs A I Baqarah. verse 60; Qs. AI Baqarah, paragraph I I)*

And remember when Moses asked for water for his people, and we said strike the stone with your staff and spring forth from it twelve springs, indeed each tribe knew his drinking place (each) eat and drink the sustenance given by Allah, and do not roam the earth doing mischief: (Qs. Al. Bagarah, v. 60).



"And when it is said to them not to do mischief on the face of the earth, they answer verily we are the ones who make repairs' (Os AI Bagarah, verse 11)

In general health theory, it is said that disease or unhealthy conditions will occur if humans ignore the external environment, This is far millions of years ago God had warned in His Word that if man neglected to take care of his external environment then man would suffer all the consequences as would all kinds of disasters.

And (we have sent) to the inhabitants of Madyan, their brother Shuaib and he said: 0 my people, worship by you Allah, hope (reward) the last day and do not wander the earth doing mischief (36) so they lied to shame, then they were struck by a terrible earthquake and became they corpses that lay in their dwelling places (Qs Al-Ankabut, vv. 36-37)

b. Internal environment

The internal environment comes from humans which includes genetic factors, biological maturation, emotions and predisposition as well as behavior, viewed from an Islamic perspective

1. Genetic factors

Islam strongly recommends to humans to pay attention to health starting early, by taking precautions as affirmed in the word of Allah SWT and the hadith below

... And associate with them appropriately. Then if you don't like them, (then be patient) because maybe you don't like something, when God made him a lot of good. (Qs An-Nisaa, verse 19)



"Choose the seedbed of my seeds from those who are good because the offspring will settle the trap of their parents" (HR Ibn Majah)

2. Biological factors

Biological factors are factors in individuals that are able to affect one's health, in the Islamic perspective this biological factor is related to bodily functions, influenced by the source of food obtained, if the source is not good it will affect health status, especially spiritual health, as in the hadith, "it is *likened that every body that grows from the haram then hell is more important for him (HR Tirmidhi)*

3. Psychology

Psychological elements are elements that can affect a person's health status, so it needs to be conditioned so that the situation becomes calm or peaceful, sometimes physically healthy, if the psychology is disturbed then the physical becomes sick, in the Our'an it is stated that

That is, believers and their hearts are at peace by remembering Allah, remember only by remembering Allah the heart becomes at peace (Qs Ar-Ra'd, verse 28)

How fortunate is the one who cleanses his soul and what a loss is the one who pollutes his soul (Qs A.sy -Sham, verse 9-10)

4. Behavior

Behavior in the context of health according to Bloom is a factor that can affect a person's health status, In Islam humans are strongly emphasized to carry out behavioral behaviors that can ensure



their health and Allah SWT really likes people who behave to maintain health, one form is maintaining cleanliness

.. In it there are those who want to cleanse themselves, and Allah loves clean people (Qs At taubah, verse 108)

Nursing

Nursing is a form of professional service that is an integral part of health services, based on nursing knowledge and tips, in the form of comprehensive bio-psycho-socio-spiritual services, addressed to individuals, families and communities, both sick and healthy, covering the human life cycle. Nursing is assistance provided due to physical and / or mental weakness, limited knowledge, and lack of willingness to carry out daily activities independently. Assistance is also addressed to major health care providers in an effort to improve the health care system so that it is possible for everyone to achieve a healthy and productive life.

The purpose of nursing care is to achieve client independence in improving health status optimally so that nursing not only pays attention to disease prevention, but also improves healthy conditions. Nursing provides health services and care aimed at improving health and helping individuals to appropriately overcome the problem of unmet basic human needs as a result of inability, ignorance, and disability.

Nursing as a science, studies the forms and causes of unfulfilled basic human needs related to health through a fundamental study of the things behind it, and studies various efforts to achieve these basic needs by utilizing various existing and potential sources optimally, so that humans can maintain, support, maintain and improve the integrity of all basic needs. Nursing theories and concepts are implemented in an integrated manner in organized stages in the form of a nursing process which is a method of solving problems scientifically, including studies, determination of nursing diagnoses, treatment action planning, implementation and evaluation of nursing action results.

Nursing in an Islamic perspective is a manifestation of the function of humans as caliphs and servants of



God to carry out their humanity, help each other who have health problems and meet their basic needs both actual and potential, all activities are carried out by strengthening friendship which in modem nursing is called interpersonal relationships.

Nursing services provided, carried out comprehensively covering bio-psycho-socio-spiritual aspects to fellow humans and as well as more broadly (society). Nursing we believe began since the first prophet, namely the Prophet Adam (as), with the event where the first death occurred in a living being, none other than his own son. At that time they were confused about what to do with the dead man, akhimya, sent down instructions from Allah SWT.

Then Allah commanded a raven to dig through the earth to show him how he should bury his brother's body. Qabil said: "Woe to me, why can't I do like this crow, then I can bury my brother's body?" That's why he's one of those who regret it. (Qs Al- Maidah, 3 1:5

1.2. Sosiological foundation

Changes in science, technology, and globalization in the world have a direct impact on the system of services to society, including health services. The public can get information quickly and easily, so that the demands for the services provided are increasing, both in the clinic and in the community. The quality of health services provided must be guaranteed, not risky, and can provide satisfaction, including nursing services.

Nursing services provided to the community must meet international quality standards, which can ensure the safety and comfort of clients and their families. Nurses are required to appear professional when providing nursing care and are able to collaborate with various parties so that the services provided are carried out comprehensively and can meet basic needs, including the bio, psycho, social and spiritual needs of clients.

The implementation of nursing practice is based on the authority given because of the expertise developed in accordance with public health needs, scientific developments and the demands of globalization as stated in



Health Law number 36 of 2009. Nursing practice is the core of various activities in the implementation of health efforts that must be continuously improved through education, registration, certification, accreditation and continuous training as well as monitoring of nursing personnel in accordance with the development of science and technology.

The birth of Law of the Republic of Indonesia No. 38 of 2014 concerning Nursing, is the juridical basis for the recognition of nursing as a profession that has autonomy in carrying out practice and regulating its profession through an independent institution, namely the Nursing Council. Nursing is the activity of providing care to families, groups, or communities both sick and healthy. The level of understanding of nursing as a profession will be reflected, among others, in the steps taken in the development and development of nursing services / care to the community. Various levels of nursing services/care must be developed, including primary, secondary, and tertiary of nursing services/care. Nursing referrals are developed and implemented effectively and efficiently in accordance with existing health / nursing personnel and facilities, both intra-institutional nursing referrals and inter-institutional health service referrals. Various types of nursing services/care, both interdependent between professional services/care (interdependent), and services/care that are independent (*independent*) can be carried out in accordance with the nature of nursing as a profession.

1.3. Historical Foundation

The National Workshop in 1983 was the beginning of the acceptance of nursing professionalism in defining: "nursing as a form of professional service that is an integral part of health services, based on nursing knowledge and tips, in the form of comprehensive bio-psycho-socio-spiritual services, addressed to individuals, families, groups, and societies, both sick and healthy that encompass the entire process of human life. Nursing services in the form of assistance provided due to physical and mental weaknesses, limited knowledge, and lack of willingness to be able to carry out daily activities independently. Nursing is a profession that serves humans and humanity, prioritizing the interests of client health above their own interests, a form of humanistic service / care, using holistic



approach, implemented based on nursing knowledge and tips, and using the nursing code of ethics as the main guide in carrying out nursing services / care

3 Curriculum Evaluation & Tracer Study

3.1. Curriculum Evaluation

Curriculum evaluation is carried out every 3-5 years. The evaluation was carried out by holding meetings with all faculty leaders, lecturers, study program leaders, stakeholders, The Association of Indonesia Nurse Education



Centre (AINEC), alumni, and nurse professional organizations (The Indonesia National Nurses Association/INNA). The 2017 curriculum was improved referring to SNPT Number 3 year 2012 and the curriculum book had been launched by AINEC in 2021, therefore, the curriculum of the Nurse Profession Study Program has been implemented since 2022.

3.2. Tracer Study

Tracer studies are conducted annually to alumni, a maximum of the last 3 years. The results of the tracer study are used as a basis for formulating graduate profiles, LO, and development of study materials.

5 Determination of Study Material





9. Management and Mechanism of Implementation of Curriculum

In the management and implementation mechanism of the curriculum, the manager uses the PPEPP cycle: determination of the curriculum based on the Dean's Decree. The curriculum development team socialized the new curriculum to all lecturers



and educators. The study program implements the curriculum as a benchmark for graduate achievement. Curriculum evaluation is carried out periodically, which is every 3-4 years. The study program records and documents findings and analyzes curriculum implementation. After that, control over the evaluation results is carried out by the Quality Assurance (QA) of faculties and study programs. Improving the quality of the curriculum is the result of follow-up evaluation and control.



10. Closing

The curriculum is the heart of the implementation of education, therefore this very vital part needs to continue to be studied, reviewed and reorganized so that educational institutions run healthily, correctly and according to the expected goals by always adjusting the development of science and technology so that graduates of professional education have the ability to provide quality health services.

Since there have been appeals and demands from the government regarding the implementation of a learning outcomes-based curriculum according to the level in IQF, AINEC has continuously escorted the implementation of the curriculum. AINEC has prepared a curriculum book design based on the competence of undergraduate nursing education in 2006 and has been refined for use in 2008. The curriculum has been widely used by nursing education institutions in Indonesia at that time and was refined again in 2015 as the AINEC Core Curriculum. In 2021, AINEC again reviewed the Indonesian Nurses Education curriculum, and the results are expected to be an alternative or guide for Nurse educational institutions in developing curricula in their respective institutions. For this reason, the Nurse Profession Study Program after going through a review has produced the 2022 Nurse curriculum as a guide for the implementation of the Nurse Professional Study Program UIN Syarif Hidayatullah Jakarta.
